**CONDITION OF ADMISSION** : Licensed dealers holding the card allowing the exercise of a Commercial activity «flea market, antiquity» + extract KBIS up to date.

**ARTICLE 1** – Fairs, exhibitions and unpacking are open to all antique dealers and second-hand dealers equipped with their RC of the current year. The organizer shall have all the powers to decide on the selection of candidates and to settle disputes all orders, with the power to exclude offenders on the spot and at all times. No recent reproduction or copying will be allowed in the exhibition.

**ARTICLE 2** – Exposing to the event «ANTIQUES ART AND YOU» implies the acceptance, Automatic and binding, of the terms of these rules of procedure.

**ARTICLE 3** – Places must be exclusively occupied by the signatories of this request to participate in order to sell their own merchandise and remain under its responsibility. It is strictly forbidden to sublet or share the stand without prior authorization from the organization. In case of authorization to share the stand by the organizer, it will be collected for the second occupant, an amount of 95 euros including VAT, representing the application fee; This being the essential condition for participation. It is recalled that it is forbidden any exhibition and sale of objects relating to any extremist regime. No furniture will be able to leave the Park during opening hours without the permission of the surveillance company.

**ARTICLE 4** – Any application for admission will be taken into consideration only duly completed and accompanied by the total settlement. In case of withdrawal, 15 days before the opening of «ANTIQUES ART AND YOU», the exhibitor will not be entitled to any refund. If your file has already been registered, a lump sum of EUR 95 (VAT Included) Will be automatically deducted in the event of a refund. Stands rented unoccupied on the day of the opening at 9 o'clock, will be allocated by the organizer as it sees fit, without the absentee being able to claim any refund or compensation.

**ARTICLE 5** – It belongs to the exhibitors to ask their own insurance company The extension to their stand of the fire insurance they already own and possibly to take out additional insurance (flights, losses, breakages ...). The organizer for his part is insured in liability, under articles 1382 to 1386 of the Civil Code. All other damages covered by contractual guarantees must be provided individually by each exhibitor.

**ARTICLE 6** – Canvassing, peddling, advertising and other, are formally prohibited for any similar event not organized by Lab Event Factory

**ARTICLE 7** – The goods sold are under the sole responsibility of the seller until the Hand delivery (against receipt) to the buyer or his duly authorized agent or representative.

**ARTICLE 8** – Failure to comply with all or part of this by-law will result in the exclusion of the exhibitor. The exclusion may take place at the discretion of the organizer without taking account of ongoing correspondence and / or unpacking in progress or already carried out and in accordance with Stipulations of the preceding articles. Please note that the labeling of the goods is mandatory.

**ARTICLE 9** – No frippe and porters may be exposed without prior notice when applying for admission, and without authorization from the organizer.  
The Organizing Committee reserves the right to accept a limited number of selected carpet dealers.

**ARTICLE 10** – Aisles and clearances must remain free during the duration of the event.  
Exhibitors must not encumber the walkways, encroach on them or in any way interfere with their neighbors.
